NOTICE OF PUBLIC HEARING RELATED TO POTENTIAL ACCEPTANCE OF THE CONVEYANCE OF PROPERTY IN THE MORNINGSIDE AND DEER RUN NEIGHBORHOODS; AND NOTICE OF REGULAR BOARD OF SUPERVISORS MEETING.

The Board of Supervisors ("Board") of the Meadow Pointe II Community Development District will hold a Public Hearing and a regular meeting on Wednesday, December 20, 2023 at 6:30 p.m. at the Meadow Pointe II Clubhouse, located at 30051 County Line Road, Wesley Chapel, Florida 33543.

The purpose of the Public Hearing is to receive public comment and objections on the District's consideration of acceptance of a conveyance of property from Pasco County in the Morningside and Deer Run neighborhoods (including but not limited to roadways, sidewalks, and related parcels). The Board will also consider any other business which may properly come before it at the regular meeting. The Public Hearing and meeting are open to the public and will be conducted in accordance with the provisions of Florida Law for Community Development Districts. The Public Hearing and meeting may be continued to a date, time, and location to be specified on the record at the hearing and/or meeting without additional publication of notice.
